## **TERMS & CONDITIONS OF ROYAL NIAGARA WEEKDAY OPPORTUNITY MEMBERSHIP**

### **2012 Membership Fees:**

An annual fee of \$1,495.00 plus applicable taxes is payable on approval of your application and issuance of your Golf Membership Card.

### **2012 Membership Privileges and Policies:**

**Members have no equity or ownership rights in or to any of the Kaneff Courses.** Members are entitled only to the privileges listed below:

#### **Privileges:**

1. Members shall have full playing privileges to Royal Niagara GC.
2. Members shall have full billing privileges at Royal Niagara GC (see billing policy below).
3. Members shall have no reciprocal playing rights at other KaneffGolf facilities.
4. Members shall receive a 10% discount off of golf lessons with a CPGA instruction at Royal Niagara GC.
5. Members shall receive a 20% discount off of full retail pricing on all Pro Shop soft good purchases.
6. Members shall receive a 10% discount off of full retail pricing on all Pro Shop hard good purchases.
7. Members shall receive a 10% discount on rental fees for Royal Niagara GC meeting and function rooms.
8. Members shall receive complimentary use of practice facilities.

#### **Policies:**

##### **MEMBERSHIP TERM AND COURSE AVAILABILITY**

The 2012 annual membership term will be from January 1, 2012 or the date of application acceptance, whichever date is later, to December 31, 2012. Club memberships are valid for the calendar year only. However, golf services and privileges are limited to the golf season only and are subject to the availability of the facility.

##### **TEE TIME RESERVATIONS AND REGISTRATION**

Members will have the ability to reserve tee times up to fourteen (14) days in advance. All members must personally register with the Pro Shop prior to play.

##### **TEE TIME CANCELLATIONS**

Tee-time cancellations are required 48 hours prior to play regardless of weather conditions. A cancellation number will be provided for your records. Failure to properly notify the Pro Shop of a cancellation will result in the full amount of the booking being charged directly to the member that made the reservation.

##### **CART USE**

Cart use, subject to appropriate fees, is mandatory at Lionhead prior to 3pm daily.

##### **BILLING**

With the exception of special events (tournaments, banquets, etc.), members will be entitled to charge all purchases to their account for monthly billing. Each member will receive an end of month statement summarizing all monthly purchases and payments to the account. The member authorizes the Kaneff Courses to charge the credit card listed in this Application for all charges incurred by the cardholder at the Kaneff Courses. At each month end, all outstanding items will be charged to the member's preauthorized credit card. Delinquent accounts will be subject to an interest rate of 2% per month and may result in suspension of account.

##### **GENERAL**

Members must present their Golf Membership Card for all account transactions, and must state their golf membership number when booking golf tee-offs. Golf members and their guests must abide by both KaneffGolf and Royal Niagara GC rules and regulations and respect the rights of all fellow golfers, guests and staff members. Failure to do so may result in the member's privileges being suspended by the General Manager. Suspended members are not entitled to any refund of the membership fee but may appeal their suspensions to the Vice President of KaneffGolf.
